What are Cookies?

Cookies are small text files stored on your device (e.g., computer, tablet, or smartphone) when you visit a website. They help remember user preferences, improve functionality, enhance security, and track site usage.

Types of Cookies We Use

- **Essential Cookies:** Required for core website functions such as security, session integrity, and accessibility.
- Analytical Cookies: Help us understand how visitors interact with the site, such as which pages are viewed and for how long (e.g., Google Analytics).
- Performance Cookies: Measure performance and ensure efficient page loading.
- Marketing Cookies: May enable retargeting or interest-based advertising via platforms like Google Ads or Meta Pixel.
- Third-party Cookies: Placed by integrated tools such as Stripe, Calendly, or YouTube. These providers have their own cookie and privacy policies.

What Data is Collected via Cookies?

Cookies may collect: - Browser type and device information - IP address and approximate location - Pages visited and time spent - Click patterns and navigation - Session or login identifiers (if applicable)

How We Use This Data

We use cookie-derived data to: - Ensure website security and prevent fraud - Monitor site performance and usability - Measure the success of marketing or awareness campaigns - Satisfy legal obligations (e.g., AML/CFT data monitoring)

Cookie Consent and Control

Upon visiting our site, a cookie banner allows you to accept or reject non-essential cookies. You can manage or update your cookie preferences at any time using your browser settings.

Cookie Duration

- Session Cookies: Deleted once you close your browser.
- Persistent Cookies: Remain until manually deleted or expired.

We retain cookie data only as long as necessary to fulfil the purposes listed above.
